

# KANSAS LEGISLATIVE UPDATE





## Week of January 22nd, 2024

The KC Chamber/KC Civic Council team had a busy week in Topeka. Tuesday, Joe Reardon with the Chamber and Megan Crook with the Civic Council were both in Topeka for meetings and hearings. The House held a vote on one bill this week, while the Senate voted on multiple resolutions. Committees in both chambers held hearings on multiple bills that are making there way through the legislative process. Next week, the Legislature plans to vote on an override of the Governor's veto of the tax plan.

### National Guard Tax Credits (HB 2544)

The House Commerce Committee held final action and approved HB 2544, which encourages businesses to hire and retain members of the Kansas National Guard by offering a tax credit to those who hire members and a tax credit to those who choose to serve. There was one amendment that would not allow employers or members of the national guard who are outside Kansas to participate in the tax credit. National Guardsman would only be able to qualify during the months that they are employed with the National Guard and are of good standing. The amendment also capped the tax credit at \$5,000. HB 2544 will now head to the House floor for a vote.

The **KC Chamber** was joined by the Kansas and Wichita chambers in support of the legislation. There were no opponents.

#### **World Cup Hearings**

Katherine Holland, Executive Director of KC 2026, Neal Sharma, Vice President of the KC 2026 Executive Board, and Joe Reardon, KC Chamber/KC 2026 Board member presented to multiple committees this week on the World Cup budget ask. The Governor included \$20 million in her budget allocated to World Cup and KC 2026 is also asking for additional \$8 million, for a total of \$28 million. This accounts for 17% of the total budget for KC 2026 and the estimated economic impact to the state is around \$163.1 million.

#### **Governor's Tax Proposal**

The Senate Tax Committee held two days of hearing on SB 377 which is the Governor's tax proposal. As previously noted, the Governor's tax proposal is very similar to House/Senate Leadership tax proposal with a couple of exceptions. Proponents of this legislation discussed Governor Kelly's plan includes a back-to-school tax holiday which will be held the same weekend as Missouri's, and the removal of taxes on feminine hygiene products and diapers. Many of the proponents were high school girls who discussed the removal of the feminine hygiene tax. The Governor's tax plan will cost the state \$1.1 billion over three years, Republican leadership's plan will cost the state around \$1.6 billion over three years. Next week, the Legislature will take up a vote on the Governor's veto. The House and Senate each need a 2/3 majority to override a veto.
